Fat Content of Ground Beef and Sausage 1991

SUMMARY

Of 221 ground beef samples tested, 54 (24.4%), contained an excess of fat. Four of 64 sausage samples tested also contained an excess of fat. Four ground turkey products were examined and all contained excess fat.

Fat Content of Ground Beef and Sausage 1991

Products labeled as ground beef or sausage must meet Connecticut (Regulations 1990) and Federal Regulations (Code of Federal Regulations). Federal Regulations for ground beef only allow a maximum of 30% fat. Current Connecticut Regulations (Regulations 1990) state that ground beef with a specific name, e.g. lean, diet lean, or designating a specific cut of meat, e.g. sirloin or chuck, must conform to the maximum amount of fat allowed (Table 1). If products specify a fat content, e.g. not more than 20% fat, or not less than 80% lean (20% fat) (Administrative Regulations), or are labeled with a specific cut of meat, e.g. ground round, or with dual labeling, e.g. extra lean ground chuck, then the most stringent Regulation applies. Products with excess fat are considered misbranded (CT General Statutes 1989).

Sausage cannot contain more than 50% fat unless labeled as *Italian*, which can contain not more than 35% fat. Up to 3% added water is allowed in sausage (Code of Federal Regulations), and up to 3.5% binders or extenders. Products labeled as *ground pork* cannot contain more than 30% fat.

METHODS

Samples were collected from January 1, 1991 to
December 31, 1991 by inspectors of the Food Division of
the Connecticut Department of Consumer Protection. In
all, 221 ground beef, 62 sausage, and six miscellaneous
samples were collected. Most samples were from food
stores, but some were from restaurants and fast food
establishments. Samples were delivered to the laboratory
and either tested immediately or frozen until tested.
Analyses were performed by methods described in Official
Methods of Analysis (Official Methods). Fat is expressed
as percentage of the fresh weight of the product.

Because of the inherent variability in sampling and in analysis, only samples found to be greater than one percentage unit above the regulated standard, or above the claim stated on the label, were considered to contain excess fat.

RESULTS AND DISCUSSION

Ground Beef: The fat contents of the 221 ground beef samples tested are shown in Table 2. Following the name of the vendor is the town where the merchant or restaurant is located. The percentage of fat found is then shown. Those with an excess of fat are followed by a plus (+) sign. In the next column, the maximum amount of fat allowed for that sample is listed, except if a claim for a lower fat content is made, then that claim is listed. For example, a product may be labeled as ground round (maximum fat allowed is 15%) but the label also may state that it contains not more than 10% fat, or not less than 90% lean (10% fat). In this case the 10% fat maximum is used.

Samples with a # sign after the vendor's name cannot be labeled as ground beef since they contained fillers and additives (Table 2).

Of the 221 ground beefs tested, 54 or 24.4% contained excess fat. This is a higher percentage than found in 1990 when 17.3% contained an excess (Bulletin 892). From 1982 to 1989, the percentage of samples with an excess ranged from 8 to 11 (Bulletins 816, 837, 858, 882). Before 1991, unless a specific claim for fat content was made, the product only had to comply with the maximum of 30% fat, even if it was labeled as containing a specific cut of meat.

In 1991 vendors may have had difficulty in adjusting their processing to meet the new regulations (Regulations 1990), and the higher percentage may reflect this.

A summary of the fat contents in all categories of products is shown in Table 3. The highest percentage of excesses of fat, 37.9%, was in products labeled as diet lean, although those labeled as lean and ground chuck were also high, 32.4 and 30%, respectively. The category with the least number of excesses was that with no designation, and thus only had to comply with the 30% fat maximum. Also in Table 3 is the average percentage of fat within categories. Only among products labeled as diet lean was the average above that allowed (10%) in the regulations. In all categories, the range of fat contents was wide.

Sausage: All sausage samples tested, listed by vendor, amount of fat found, and label designation, are shown in Table 4. Those with excess fat have a plus sign (+) after % fat found. Among the 64 sausage samples tested, 23 were regular sausage and only had to conform to a 50% fat maximum. Forty-one samples were labeled as Italian sausage and had to conform to a 35% fat maximum. In all, only four regular samples, or 17.4%, contained an excess of fat (Table 3). None of the Italian types contained an excess of fat (Table 4). The average fat content of regular sausage was 30.5%, and 21.1% for Italian sausage (Table 3). In 1990 no sausage was found with excess fat (Bulletin 892). Four products (a * after % fat found) contained an excess of filler (Table 4). The samples labeled as ground pork or pork meat pattie contained an excess of fat because the maximum allowed for such products is 30%.

Miscellaneous products: Six miscellaneous products were tested (Table 5). These included four labeled as ground turkey and two hot dogs. All the ground turkey products contained excess fat, and three of these were labeled as fat free.
