LEGAL UPDATE

The Connecticut Supreme Court released its decision in the case entitled Commission on Human Rights and Opportunities v. Housing Authority of the Town of Litchfield, et al., on Thursday, August 11, 2011 (the official release date is August 23, 2011).

The basis of the appeal was the interpretation of a CHRO statute that allows for the relator complainant to intervene as a party when his/her housing case is elected to proceed in Superior Court. The Court determined that it had "improvidently granted certification" and it dismissed the appeal of the Litchfield Housing Authority. The Court primarily based its decision on the passage of a pubic act that unequivocally allows for the intervention of a relator, as of right, in his/her Superior Court matter. The Court found this change in the statute very persuasive and therefore dismissed the appeal. Congratulations to CHRO Attorney Michelle **Dumas** Keuler and thank you to the General Assembly for the passage of the public act.

The 2011 **Anti-Bullying** Leadership Conference focused fighting discrimination, protecting the rights of children in schools and reducing discriminatory bullying on August 10, 2011. Connecticut parents students, teachers, administrators and school board members met at the state capitol to discuss the consequences of discriminatory bullying in Connecticut schools. Dr. Bill Howe and Dr. JoAnn Frieberg school climate and bullying consultants to the Department of Education spoke to the standing room only crowd about the role the state Department of education plays in creating positive school culture and eliminating bullying. Tregoning, Program Manager with the Governor's Partnership prevention discussed the work the Agency does in assisting schools with developing a positive and respectful school climate.



Representative Gail LaVielle. who represents Norwalk and Wilton and serves on the Education Committee, spoke to the receptive audience about the reality of bullying in Connecticut schools and about the work that the Education Committee has done to improve school climate. CHRO Attorneys Kimberly Jacobsen, Cheryl Sharp, Alix Simonetti and Michelle Dumas Keuler talked about the history of the Agency, the complaint process and coverage of discriminatory bullying. Interns Jonathan Pike and DJ Arnold were chief organizers of the event.



Parents shared heartfelt stories about the devastating effects of bullying on their children. It was clear from the Conference that words hurt and that students have to say something if they see or hear discriminatory bullying.
