At a public meeting of the Connecticut Siting Council (Council) held on September 17, 2015, the Council approved the transfer of the Certificates of Environmental Compatibility and Public Need (Certificates) from CoxCom, LLC d/b/a Cox Communications New England to InSite Towers, LLC for the following Community Antenna Television facilities:

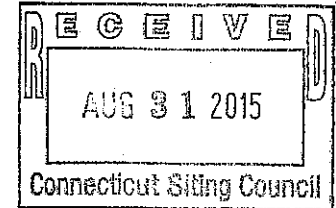

Dear Attorney Bachman:

Our firm represents CoxCom, LLC d/b/a Cox Communications New England ("Cox" or "the Company") in connection with certain Connecticut regulatory issues. Based on our recent communications, we have become aware that the Connecticut Siting Council ("the Council") had not been apprised that certain of Cox's community antenna television ("CATV") towers were transferred to InSite Towers, LLC ("InSite") on or about May 31, 2012. It had been Cox's understanding that InSite was going to report the transfer of ownership to the Council, which evidently was not done. On behalf of Cox, please accept our sincerest apologies for any inconvenience this omission may have caused the Council. Further, Cox understands that InSite still owns and operates these towers as telecommunications towers, not as CATV towers, as Cox has no facilities attached to or deployed on these towers.

In any event, for the Council's records the following CATV towers were transferred to InSite:

- 577 Bell Street Glastonbury
- 157 Chestnut Hill Stafford
- 107 Stickney Rd. Union
- 55 King Spring Rd. Windsor Locks
- South Grand St. East Granby
- Town Farm Rd. Enfield
- Mountain Rd., Hartland

Please note that the towers in Stafford, Union, Windsor Locks, East Granby, Enfield and Hartland were originally constructed by Continental Cablevision, which was then acquired by MediaOne, prior to the transfer to Cox, which was approved by the Department of Public Utility Control in 1999. See Decision, Docket No. 99-03-40, *Application for Approval of the Transfer of the Certificate of Public Convenience and Necessity and Other Assets of MediaOne of Western New England, Inc. to CoxCom, Inc.* (July 21, 1999). At this time, the Company does not own any certificated facilities that are within the jurisdiction of the Council.

If you have any questions or require additional information, please feel free to contact me. Again, on behalf of my client, we deeply regret any confusion or administrative inconvenience caused by the transfer to Insite. Thank you for your consideration.
