1. Manner in which petitioner claims to be substantially and specifically affected:

Marian Larkin is the owner, both individually and as a co-owner with other family members, of significant real estate, a large portion of which is located within approximately one mile of the proposed facility. She is the manager of Greenfields, LLC which is a family-owned limited liability company that also owns significant real restate within approximately one mile of the proposed facility. The properties in which petitioner has an interests consist mostly of land that is devoted to use as farm or forest land and conservation purposes.

The proposed facility will have a material and adverse impact on the land that petitioner owns or has an interest in on account of the following:

- The rural character of the land would be irretrievably compromised by the physical impact of the facility and the results of its operations.
- The ridgeline as seen from the property would be severely compromised.
- The potential for future development of the land and the value of the land for such development would be damaged by the location of and emissions from the facility.

- Emissions from the facility both odor and particulate matter will be a health hazard for those
 people living on the property or using the property for equestrian and other recreational uses,
 including the Larkin Bridle Trail, a State-recognized and protected regional asset.
- Emissions from the facility will adversely impact on the haying operations conducted as part of
 the farm uses by reducing the quality and quantity of hay and introducing hazardous or toxic
 substances into the hay. Similarly, the emissions will adversely affect the forest land/timbering
 operations by reducing the quantity and quality of timber produced in the forest areas.
- Emissions from the facility will have a deleterious impact on the eco-systems of the property and adversely impact on wildlife and habitat.
