It is with great pleasure that I am writing in support of the proposed *CPV Towantic Energy Center*, a 805 MW natural gas fired combined cycle electric generating facility to be constructed on a 26-acre site located in the Woodruff Hill Industrial Park in Oxford, CT.

The Greater Valley Chamber of Commerce is the premiere voluntary business association serving the Naugatuck Valley region of Connecticut, which includes the Town of Oxford along with the neighboring towns of Seymour, Beacon Falls and the Lower Valley communities of Ansonia, Derby and Shelton. Over the past several decades, the Valley region has emerged as a major center of economic influence, while Oxford itself has earned the distinction as one of the fastest growing Towns in the State of Connecticut.

As such, the Chamber and our more than 500 member businesses have taken a vital interest in the CPV Towantic Energy Center Project and are excited about the many benefits that it will bring to our region. In fact, the Chamber was pleased to host an informational breakfast on Friday, September 26th entitled "Powering Up the Valley: Meeting the Energy Needs of a Growing Economy" which featured an Overview of the CPV project along with a report on UI's new Electric Substation, which is now under construction on Old Stratford Road in Shelton.

During this breakfast presentation, we learned of the significant and positive economic benefits that this project will bring to our region to include 300-500 construction jobs during construction, approximately \$22 Million in sales tax revenue and more than \$50 Million in property tax revenue over the life of the project. Far more important than these local benefits is the impact this project will have in helping to meet the growing need for safe and reliable electric generating capacity to fuel the continued growth of our Connecticut economy.

The CPV Towantic Energy Center is ideally located at the confluence of the Algonquin Interstate Pipeline and the Connecticut Light & Power (CL&P) 115 KV Circuit in a secluded and permitted site adjacent to the Waterbury-Oxford Airport. This project represents a private sector infrastructure investment of over \$1 Billion and will produce enough electricity to power approximately 800,000 homes and businesses.

At a meeting of the Chamber Board of Directors held on Thursday, December 4th, the Board adopted a resolution authorizing me to write this letter of support and to provide testimony at future Public Meetings of the Siting Council, which I look forward to providing in the weeks ahead. Until then, thank you for your consideration of this letter and for all that you do in advancing Connecticut's economic growth by meeting its energy needs.
