Ladies and Gentlemen:

Pursuant to Condition No. 5.a of the Connecticut Siting Council's Decision and Order, dated May 14, 2015, CPV Towantic, LLC ("CPV Towantic") hereby submits its Quarterly Progress Report for the 3<sup>rd</sup> Quarter of 2015.

The status of the Project's permits during Q3-2015 is as follows:

- On July 2, 2015, the Town of Middlebury et al. filed an appeal in New Britain Superior Court of the Connecticut Siting Council's Decision and Order, dated May 14, 2015.
- On July 17, 2015, CPV Towantic submitted its Development and Management Plan to the Connecticut Siting Council.
- On July 20, 2015, CPV Towantic submitted its application for registration under the CT DEEP's General Permit for the Discharge of Stormwater and Dewatering Wastewaters from Construction Activities.
- On July 27, 2015, the CT DEEP issued its Tentative Determination to approve CPV Towantic's New Source Review Air Permits.
- On August 20, 2015, in conjunction with the Town of Middlebury et al.'s appeal, a settlement conference amongst the parties was convened by Judge Levine in New Britain Superior Court.
- On September 3, 2015, the Connecticut Siting Council approved CPV Towantic's Development and Management Plan, with the exception of "item e."
- On September 8, 2015, in conjunction with the Town of Middlebury et al.'s appeal, another settlement conference amongst the parties was convened by Judge Levine in New Britain Superior Court.
- On September 16, 2015, the Federal Aviation Authority denied Mr. Raymond Pietrorazio's petition for a discretionary review.

- On September 17, 2015, the CT DEEP and CPV Towantic conducted a public informational hearing at Oxford High School for CPV Towantic's proposed New Source Review Air Permits.
- On September 17, 2015, the Connecticut Siting Council approved "item e" of CPV Towantic's Development and Management Plan.
- On September 23, 2015, the Office of State Traffic Administration issued an Administrative Determination to CPV Towartic stating that the project will not substantially affect state highway traffic operations in the area.
- On September 25, 2015, CPV Towantic agreed to the Town of Middlebury et al.'s request for a nine day extension until October 7th for the Plaintiffs to file their merit brief.
- Limited tree clearing for the purposes of silt fence isolation barriers began on September 28, 2015.
