PUBLISHER'S CERTIFICATE

Notice is hereby given, pursuant to Section 16-501(b) of the Connecticut General Statutes and Section 16-501-1(e) of the Regulations of the Connecticut State Agencies of any application to be submitted to the Connecticut Siting Council ("Siting Council") on June 25, 2007, and thereafter by MCF Communications, Inc. ("MCF") and Omnipoint Communications, Inc. ("Omnipoint") a subsidiary of T-Mobile USA, Inc. ("T-Mobile") (collectively the "Applicants") in the County of New London, State of Connecticut, to request a certificate of environmental compatibility and approval from the Siting Council for the construction, maintenance and operation of a telecommunications facility in Groton, Connecticut. Applicants are proposing to construct a monopole tower at 237 Sandy Hook Road, Groton, Connecticut and is owned by the Groton Ambulance Association ("Property"). The Applicants propose to construct a 130 foot, self-supporting tower with antennas, associated equipment and site improvements integral to a telecommunications facility. The location of the proposed facility is subject to review and potential changes pursuant to the provisions of the Connecticut General Statutes § 16-50g et. seq. The proposed Facility will provide service to the Town of Groton, along Interstate 95, as well as in adjacent areas. The Applicants will explain the need, purpose and benefits of the facility and will also describe the potential impacts of the proposed facility. A balloon representative of the proposed facility height will be flown on the day of the Siting Council public hearing on the proposed facility which will take place in the Town of Groton on June 25, 2007. The balloon will be flown from 8:00 a.m. to 6:00 p.m. Notice of the public hearing date will be provided by the Siting Council.
