Follow I-95 north to exit #89 for Allyn Street Turn right onto Allyn St. Follow Allyn St. to intersection with Sandy Hollow Rd, Groton Turn right onto Sandy Hollow Rd site will be on the left. (an orange cone will mark location)

From I-95 Southbound

Follow I-95 south to exit #89 Allyn St Turn left onto Allyn St. cross under the highway Follow Allyn St. to intersection with Sandy Hollow Rd, Groton Turn right onto Sandy Hollow Rd; site will be on the left. (an orange cone will mark location)

TO GROTON TOWN HALL ANNEX HEARING SITE

From Field Review Site

Head east on Sandy Hollow Rd toward Allyn St Turn right at Allyn St go 1.2 miles Turn right at New London Rd/US-1 go 2.1 miles Turn left at CT-215/Groton Long Point Rd go 0.3 miles to 134 Groton Long Point Rd. Town Hall Annex.


From I-95 Northbound

Follow Route 117 to the intersection of US Route 1
At light turn left onto US Route 1
Follow US Route 1 to the intersection with Route 215
Turn right onto Route 215
134 Groton Long Point Road Town Hall Annex will be on the left.

From I-95 Southbound

Follow I-95 south to exit #89 Allyn St
Turn left onto Allyn St. cross under the highway
Follow Allyn St 1.3 miles
Turn right at New London Rd/US-1 go 2.1 miles
