TO FIELD REVIEW:

Cove Road, Haddam Neck

FROM ARRIGONI BRIDGE, MIDDLETOWN

Follow Route 66 east over the Arrigoni Bridge, proceed through Portland. Take right onto Route 151 south (traffic light in Cobalt). Follow 151 past traffic light for Hurd State Park.

Take right on Haddam Neck Road on right. (Approx. 1 mile past Hurd Park turnoff).

From Haddam Neck Road, take left onto Quarry Hill Road, after powerlines.

From Quarry Hill Road, take left onto Cove Road (old white colonial on corner).

Site will be on right before powerlines.

From I-91 (Hartford/New Haven)

Follow I-91 to Route 9 south (Exit 22).

Follow Route 9 south to Route 66 east (first traffic light on Rt. 9 - take right) to Arrigoni Bridge - Follow directions above.

From I-84/I-691 (Waterbury/Meriden)

Follow I-84 east to I-691 east through Meriden.

From I-691 in Meriden, take exit for I-91 north.

Follow directions above for I-91.

From Route 9 (Old Saybrook)

Follow Route 9 to Exit 7, Route 82 east.

Follow Route 82 east over CT River to Route 149 north in East Haddam village.

Follow Route 149 north to Route 151 north.

From Route 151 north, take left onto Haddam Neck Road.

From Haddam Neck Road, take left onto Quarry Hill Road, after powerlines.

From Quarry Hill Road, take left onto Cove Road (Old white colonial on corner).

Site will be on right before powerlines.

TO HEARING 21 Field Park Road, Haddam

From Cove Road, turn right onto Quarry Hill Road.

Turn right onto Haddam Neck Road.

Turn right onto Route 151 south.

Follow Route 151 south to Route 149 south.

Follow Route 149 south to Route 82 west in East Haddam village, go over CT River bridge.

Turn right onto Route 154 north.

Turn left onto Field Park Drive in Haddam center (after library).

Old Academy is the stone building on right.

From I-91 (New Haven/Hartford)

Follow I-91 to Route 9 south.

Follow Route 9 south to exit 10, Aircraft Road.

Take right at end of ramp onto Route 154 south.

Follow to Field Park Drive on right (after Thankful Arnold House).

Old Academy is the stone building on right.

From I-84/I-691 (Waterbury/Meriden)

Follow I-84 east to I-691 east through Meriden.

From I-691 in Meriden, take exit for I-91 north.

Follow directions above for I-91.

From Route 9 (Old Saybrook)

Follow Route 9 to Exit 7, Route 82 east.

From Route 82, follow Route 154 north.

Turn left onto Field Park Drive in Haddam center (after library).

Old Academy is the stone building on right.

Turn right out of Field Park Drive onto Saybrook Road (Rt. 154 south) Continue on Saybrook Road to Haddam Pizza on right in vicinity of Route 82 intersection.
