
In response to your request of January 14, 2008, on January 24, 2008, the Connecticut Siting Council (Council) granted you intervenor status in Docket No. 348.

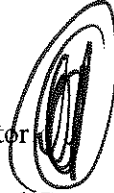
