DOCKET NO. 350 - Cellco Partnership d/b/a Verizon Wireless application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance and operation of a telecommunications facility located off Old Turnpike Road and Route 198, Woodstock, Connecticut.

#### I. Introduction

The application is from Cellco Partnership d/b/a Verizon Wireless (Verizon Wireless) for the construction, maintenance, and operation of a telecommunications facility and associated equipment in the Town of Woodstock, Connecticut.

Verizon Wireless proposes to erect a 140-foot steel monopole telecommunications tower on an 53.6 acre parcel located north of Old Turnpike Road and east of Route 198 in Woodstock. The tower would be built within a 60-foot by 60-foot enclosed compound.

#### II. Technical

The application includes relevant maps, descriptions of the proposed prime and alternate site, costs, a description of the environmental effects of the proposed construction, and health and safety information. The application meets statutory technical requirements for processing the application. Council staff believes additional information can be obtained through prehearing interrogatories. This project would not require an outside consultant.

#### III. Administrative Review

The applicant has stated that all service and filing requirements pursuant to General Statutes § 16-501 (b) have been fulfilled. The applicant stated that notice to the general public was published in the *Norwich Bulletin* on October 23 and 24, 2007.

#### IV. Procedural

The Council must schedule a hearing for the proceeding between 30 and 150 days after receipt of an application. The Council must also appoint a custodian of the docket and designate a place for the deposition of the transcript. Staff recommends designating Carriann Mulcahy as custodian of the docket, holding the public hearing in the Town of Woodstock on February 7, 2008, and depositing the transcript in the Woodstock Town Hall.
