Cellco Partnership d/b/a Verizon Wireless ("Cellco") will be submitting an application to the Connecticut Siting Council ("Council") on or about October 26, 2007, for approval of the construction of a telecommunications facility off Route 198, north of Old Turnpike Road in the Town of Woodstock, Connecticut.

The proposed location would consist of a new 140-foot, self-supporting monopole telecommunications tower and a 12' x 30' equipment shelter located on a 53.6-acre parcel. The parcel is owned by Michael and Sandra M. Walsh. An on-site backup generator would also be installed inside Cellco's shelter. The tower would be designed to accommodate multiple carriers.

The location and other features of the proposed facility are subject to change under the provisions of Connecticut General Statutes § 16-50g et seq.

State law provides that owners of record of property which abuts a parcel on which the proposed facility may be located must receive notice of the submission of this application. This notice is directed to you either because you may be an abutting land owner or as a courtesy notice.
