1. Manner in which petitioner claims to be substantially and specifically affected:

I am a property owner on Lake Street, the proposed site for a cell tower, with a minimum height of 110 feet. My family would be specifically affected as my home /property is abutted to the property seeking permission to install the cell tower and benefit handsomely monetarily from doing so. My family and I would have full view of the proposed tower, as it will sit atop a hill in my immediate back yard. It will be highly visible12 months a year, no screening. I have concerns about safety and about devaluation of my property that has been in my family for forty years. I have several concerns to address. I realize that this is very last minute. I am throwing myself at the mercy of your discretion in these proceedings.

2. Manner and extent to which petitioner proposes to participate:

I have contacted several attorneys and expect to engage in legal council with one within one day or two at most. I am a concerned home owner, parent and tax payer .My property does abut the applicants .As this is coming to you very late, I-would like to request that you waive my rights to cross examine today at the 3:00 hearing
