NOTICE

Notice is hereby given, pursuant to Section 16-501(b) of the Connecticut General Statutes and Section 16-501-1(e) of the Regulations of Connecticut State Agencies of an Application to be submitted to the Connecticut Siting Council ("Siting Council") on October 31, 2007 or thereafter by Omnisite Towers LLC and Omnipoint Communications, Inc., a subsidiary of T-Mobile USA, Inc. ("T-Mobile") (collectively the "Applicants"). The Applicants will request a certificate of environmental compatibility and public need from the Siting Council for the construction, maintenance and operation of a telecommunications facility in Manchester, Connecticut. The Applicants are proposing to construct a new monopole tower at 93 Lake Street, Manchester, Connecticut and is owned by Alan C. Rossetto (the "Property"). The Applicants propose to construct a new 110' self-supporting monopole tower, antennas, associated equipment and other site improvements integral to a wireless communications facility. The location, height and other features of the proposed facility are subject to review and potential change under provisions of the Connecticut General Statutes § 16-50g et. seq. The proposed facility would provide personal wireless communication service in the Towns of Manchester along Route 44/Route 6 and in adjacent areas, which do not have adequate service. The Application will explain the need, purpose and benefits of the facility and will also describe the environmental impacts of the proposed facility.

A balloon representative of the proposed height will be flown on the day of the Siting Council public hearing on the Application, which will take place in the Town of Manchester. The balloon will be flown from approximately 12 p.m. to 5 p.m. Notice of the public hearing date will be provided by the Siting Council.
