Cellco Partnership d/b/a Verizon Wireless ("Cellco") will be submitting an application to the Connecticut Siting Council ("Council") on or about November 20, 2007, for approval of the construction of a telecommunications facility at one of two locations in the Town of Watertown, Connecticut.

The first proposed location ("Site A") would consist of a new 150-foot, self-supporting telecommunications tower and a 12' x 30' equipment shelter located on a vacant 0.24 acre parcel off Old Baird Road. This parcel is owned by The Town of Watertown. An on-site backup generator would also be installed inside Cellco's shelter. The tower would be designed to accommodate multiple carriers. Access to Site A would extend directly from Old Baird Road.

The second proposed location ("Site B") would consist of a new 160-foot, self-supporting telecommunications tower and a 12' x 30' equipment shelter located on a 13.70 acre parcel off Old Baird Road. The parcel is also owned by the Town of Watertown and is the site of the Town's Highway Department maintenance facility, Solid Waste Transfer Station and Animal Shelter. A back-up generator would also be installed inside Cellco's shelter. The tower would be designed to accommodate multiple carriers. Access to Site B would extend from Old Baird Road, over existing driveways on the Town property to the cell site.

The location and other features of the proposed facility are subject to change under the provisions of Connecticut General Statutes § 16-50g et seq.




