Pursuant to Section 16-50j of the Connecticut General Statutes, as an abutting property owner, this is to notify you that, Optasite Towers LLC, with a principal place of business at One Research Drive, Suite 200C, Westborough, MA 01581 and Omnipoint Communications, Inc. with a Connecticut office at 35 Griffin Road South, Bloomfield, CT 06002 (collectively the "Applicants"), will file an application with the Connecticut Siting Council regarding a proposal to construct a telecommunications facility at one of two alternate parcels of property. Site A is located at 58 Montano Road in Glastonbury and Site B is located at 618 Neipsic Road (a/k/a 497A Wickham Road). The application will be submitted to the Connecticut Siting Council on or about March 17, 2008 and the Applicants will request to be put on a future agenda.

NOTICE

Notice is hereby given, pursuant to Section 16-501(b) of the Connecticut General Statutes and Section 16-501-1(e) of the Regulations of Connecticut State Agencies of an Application to be submitted to the Connecticut Siting Council (“Siting Council”) on March 14, 2008 or thereafter by Optasite Towers LLC and Omnipoint Communications, Inc., a subsidiary of T-Mobile USA, Inc. (“T-Mobile”) (collectively the “Applicants”). The Applicants will request a certificate of environmental compatibility and public need from the Siting Council for the construction, maintenance and operation of a telecommunications facility in Glastonbury, Connecticut. The Applicants are proposing to construct a new monopole tower at one of two alternate locations in the Town of Glastonbury. The first site is located at 58 Montano Road in Glastonbury, is owned by Rose Marie Shaw and is identified as alternate Site A (the “Site A Property”). The second site is located at 618 Neipsic Road also known as 497A Wickham Road in Glastonbury, is owned by Joanne Sullivan LLC and is identified as alternate Site B (the “Site B property”). The Applicants propose to construct a new 120’ self-supporting monopole tower at the Site A Property or a 130’ self-supporting monopole tower at the Site B Property, antennas, associated equipment and other site improvements integral to a wireless communications facility. The location, height and other features of the proposed facility are subject to review and potential change under provisions of the Connecticut General Statutes § 16-50g *et. seq.*

The proposed facility, at either location, would provide personal wireless communication service in the Town of Glastonbury along State Route 2 and in adjacent areas, which do not have adequate service. The Application will explain the need, purpose and benefits of the facility and will also describe the environmental impacts of the proposed facility.

A balloon representative of the proposed height will be flown on the day of the Siting Council public hearing on the Application, which will take place in the Town of Glastonbury. The balloon will be flown from approximately 8 a.m. to 6 p.m. Notice of the public hearing date will be provided by the Siting Council.
