NOTICE

Notice is hereby given, pursuant to Section 16-501(b) of the Connecticut General Statutes and Section 16-501-1(e) of the Regulations of Connecticut State Agencies of an Application to be submitted to the Connecticut Siting Council ("Siting Council") on June 5, 2008 or thereafter by Optasite Towers LLC and Omnipoint Communications, Inc., a subsidiary of T-Mobile USA, Inc. ("T-Mobile") (collectively the "Applicants"). The Applicants will request a certificate of environmental compatibility and public need from the Siting Council for the construction, maintenance and operation of a telecommunications facility in Norwich, Connecticut. The Applicants are proposing to construct a new monopole tower located at 39 Maennerchor Avenue, Norwich, Connecticut, which is located in the Taftville section of the City. The property is owned by the Maennerchor Club. (the "Property"). The Applicants propose to construct a new 120' self-supporting monopole tower, antennas, associated equipment and other site improvements integral to a wireless communications facility. The location, height and other features of the proposed facility are subject to review and potential change under provisions of the Connecticut General Statutes § 16-50g *et. seq.*

The proposed facility, at either location, would provide personal wireless communication service in the City of Norwich and particularly along State Highway 12, State Highway 169 and within the Taftville section of the City and in adjacent areas, which do not have adequate service. The Application will explain the need, purpose and benefits of the facility and will also describe the environmental impacts of the proposed facility.

A balloon representative of the proposed height will be flown on the day of the Siting Council public hearing on the Application, which will take place in the City of Norwich. The

balloon will be flown from approximately 8 a.m. to 6 p.m. Notice of the public hearing date will be provided by the Siting Council.
