DOCKET NO. 368 - Cellco Partnership d/b/a Verizon Wireless application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance and operation of a telecommunications facility located off Sterling Road

From southwest Connecticut:

- Take I-95 northbound to I-395 northbound;
- From I-395 take exit 89 (Route 14, Moosup/Sterling) and turn left at end of exit to travel eastbound on Route 14;
- Follow Route 14 through Moosup and Almyville and across bridge over Moosup River;


From Town Hall:


- Return to Route 12 and turn right to travel southbound:
- Bear left at traffic light in front of McDonald's;
- Turn into driveway just beyond McDonald's;
- O'Connor's will be on left.

From I-395:

- Take Exit 87 and turn onto Lathrop Road to travel northbound;
- Turn into McDonald's driveway, O'Connor's will be on left.




