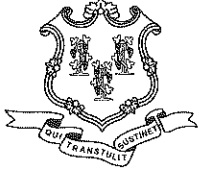
RE: **DOCKET 370** – Consolidated proceeding pursuant to the Connecticut Energy Advisory Board (CEAB) Request for Proposal (RFP) process under C.G.S. §16a-7c. **Original application:** The Connecticut Light & Power Company application for Certificates of Environmental Compatibility and Public Need for the Connecticut Valley Electric Transmission Reliability Projects which consist of (1) The Connecticut portion of the Greater Springfield Reliability Project that traverses the municipalities of Bloomfield, East Granby, and Suffield, or potentially including an alternate portion that traverses the municipalities of Suffield and Enfield, terminating at the North Bloomfield Substation; and (2) the Manchester Substation to Meekville Junction Circuit Separation Project in Manchester, Connecticut. **Competing application:** NRG Energy, Inc. application pursuant to C.G.S. §16-50l(a)(3) for consideration of a 530 MW combined cycle generating plant in Meriden, Connecticut. **NRG's Motion for Access to London Economics International LLC's (LEI) Model Price Data dated August 25, 2009. Town of Suffield and Town of East Granby Request for Scheduling on November 5, 2009. CAOPLC Objection to Town of Suffield and Town of East Granby Request for Scheduling. Additional Pre-File Testimony Deadline for CAOPLC.**

During the evidentiary hearing for the above-referenced docket held on Thursday, October 22, 2009, the Connecticut Siting Council ("Council") granted NRG's Motion for Access to LEI Model Price Data ("protected materials") under a protective order based on the proprietary nature of the information requested. The Council notes that this action is consistent with the provisions of C.G.S. § 1-210(b). The protected materials shall be filed under seal at the Council office according to the Council's Procedures for Filing Proprietary Information Under Protective Order. Any participant in the above-referenced docket seeking access to the protected materials shall execute a Non-Disclosure Agreement acknowledging receipt of the Protective Order granted by the Council and agreeing to abide by the terms thereof. **Access to the protected materials will be granted only at the Council office. No photocopying, no tape recording, no photographs, and no note-taking of any kind of the protected materials will be permitted.**

The Council also granted the request, dated October 6, 2009, filed by parties to this docket the Towns of Suffield and East Granby, to be scheduled to appear for cross examination on Thursday, November 5, 2009. The objection, dated October 9, 2009, filed by party, Citizens Against Overhead Power Line Construction (CAOPLC), to the appearance of the Towns of Suffield and East Granby on November 5, 2009 was denied.

In addition, at its regularly scheduled meeting held on October 8, 2009, the Council granted a request by CAOPLC for permission to file additional testimony and interrogatories in advance of its appearance. During the evidentiary hearing held on October 22, 2009, the Council set a deadline for the CAOPLC to submit these documents. All materials filed by CAOPLC shall be received by the Council by the close of business on Friday, October 30, 2009.
