I write on behalf of NRG Energy, Inc. ("NRG") to inform you that NRG received from the Connecticut Light and Power Company ("CL&P") Exhibits 29 through 36 on or about August 27, 2009. We understand that Ms. Frayer will sponsor these exhibits at the continued hearing on September 2, 2009. In addition to these exhibits, NRG is waiting for the Council's decision as to whether it will require that CL&P provide additional information from London Economics International LLC ("LEI") as NRG requested by letter on August 25, 2009.

In accordance with the Council's Memorandum, dated August 17, 2009, NRG respectfully requests that the Council allow NRG to submit interrogatories to CL&P regarding the referenced late-filed exhibits and the LEI data, if such data is made available. At this time, given the short time available to review and analyze the new information and the uncertainty regarding the release of the LEI data, NRG does not know whether interrogatories will be necessary. However, NRG would like to reserve its right to do so, if it does become necessary.


