

The Milford Inland Wetlands and Watercourses Agency has received a copy of the Connecticut Siting Council Application for a Telecommunications Facility at 631 Orange Avenue in Milford, CT a memo from Dean Gustafson of VHB dated 2/11/09 and the site plan entitled "Verizon Wireless, Wireless Communications Facility Milford East Facility, 631 Orange Avenue, Milford, CT 06460" by Natcomm Consulting Engineers, Inc., 1 sheet dated 7/22/08 last revised 2/5/09.

The telecommunications tower is proposed 86' from an inland wetland associated with Stubby Plain Brook in the Indian River Watershed. The original plan called for construction of a new a stormwater drainage dischage in the wetland. The 2/5/09 revision to the proposed plan uses a by-pass pipe to redirect the stormwater drainage around the proposed construction and back into the existing discharge pipe. This revision reduces the impact to the inland wetlands on the property, by keeping the work 65' from the inland wetland line. Best management practices and compliance with the 2002 Connecticut Guidelines for Erosion and Sedimentation Control during construction and until the site is stabilized should protect the resources on the site during construction. I recommend that the contractor responsible for site construction be responsible for installation and inspection of the erosion controls. This individual should be required to inspect the erosion and sedimentation controls weekly and within 24 hours of a significant precipation event to ensure that controls are in place and functioning. Reports of these inspections and any required repairs should be on file in the construction trailer for inspection by permitting authorities
