Pursuant to Connecticut General Statutes ("CGS") § 16-50n and Regulations of the Connecticut State Agencies § 16-50j-15a, Youghiogheny Communications Northeast LLC d/b/a Pocket Wireless ("Pocket") respectfully requests permission of the Connecticut Siting Council ("Council") to participate, as an intervenor, in the application and hearing process of New Cingular Wireless PCS, LLC's ("New Cingular") application for a certificate of environmental compatibility and public need for the construction, maintenance and operation of a telecommunications facility at 224 Lovely Street, Avon, Connecticut.

Pocket is licensed by the Federal Communications Commission ("FCC") to provide PCS wireless telecommunications service in the State of Connecticut, which includes the area to be served by the proposed installation. Pocket has an interest in the application process to aid the Council in evaluating the public need considerations set forth in CGS §§ 16-50g and 16-50aa.
