NOTICE

Notice is hereby given, pursuant to Section 16-501(b) of the Connecticut General Statutes and Section 16-501-1(e) of the Regulations of Connecticut State Agencies of an Application to be submitted to the Connecticut Siting Council ("Siting Council") on October 27, 2008 or thereafter by Optasite Towers LLC and Omnipoint Communications, Inc., a subsidiary of T-Mobile USA, Inc. ("T-Mobile") (collectively the "Applicants"). The Applicants will request a certificate of environmental compatibility and public need from the Siting Council for the construction, maintenance and operation of a telecommunications facility in Bloomfield, Connecticut. The Applicants are proposing to construct a new monopole tower located at 12 Burr Road, Bloomfield, Connecticut. The property is owned by the Maple Hill Farms, Inc. (the "Property"). The Applicants propose to construct a new 130' self-supporting monopole tower, antennas, associated equipment and other site improvements integral to a wireless communications facility. The location, height and other features of the proposed facility are subject to review and potential change under provisions of the Connecticut General Statutes § 16-50g et. seq.

The proposed facility would provide personal wireless communication in the Town of Bloomfield and particularly along Route 185 (Simsbury Road) and in adjacent areas. The Application will explain the need, purpose and benefits of the facility and will also describe the environmental impacts of the proposed facility.

A balloon representative of the proposed height will be flown on the day of the Siting Council public hearing on the Application, which will take place in the Town of Bloomfield. The balloon will be flown from approximately 8 a.m. to 6 p.m. Notice of the public hearing date will be provided by the Siting Council.
