TO FIELD REVIEW – 322 Beaver Brook Road

Via Interstate 91 North (from points south of Hartford):

Take I-91 North to Exit 25 (Route 3 North).
Take Route 3 North to Route 2 East (towards Norwich).
Follow Route 2 Directions below.

Via Route 2 East and/or Route 11 South:

Proceed on Route 2 East (towards Norwich).
Take Exit 19 (Route 11 South) off of Route 2 East to Route 11 South.
Proceed on Route 11 South for about 7.4 miles.
Take Exit 4 (Route 82) off of Route 11 South.
At the end of the ramp, turn right onto Route 82 (East Haddam Road).
Take first left onto Darling Road.
Proceed on Darling Road for about 0.2 miles.
The road forks into three directions.
Proceed straight to continue on Darling Road.
Proceed on Darling Road for about 1.0 miles.
Turn left onto Gungy Road.
Proceed on Gungy Road for about 2.9 miles.
Turn left onto Beaver Brook Road.
Proceed on Beaver Brook Road for about 0.3 miles.
The site is located at 322 Beaver Brook Road.
The sign is adjacent to the access drive.
Limited parking is available.

TO FIELD REVIEW – 322 Beaver Brook Road

Via Interstate 95 North (from points west of Old Lyme)

Take I-95 North to Exit 70.

At the end of the ramp, turn left onto Route 156 (heading north.)

Proceed north on Route 156 for about 2.4 miles to reach the Lyme Town Line.

Continue north on Route 156 for 4.6 miles.

Turn right onto Beaver Brook Road.

Continue on Beaver Brook Road for about 2.9 miles to the site.

The site is located at 322 Beaver Brook Road.

The sign is adjacent to the access drive.

Limited parking is available.

Via Interstate 95 South (from points east of Old Lyme)

Take I-95 South to Exit 70.

Turn left onto Route 1.

Turn right onto Halls Road.

Proceed on Halls Road for about 0.7 miles.

Turn right onto Route 156 (headed north).

Proceed north on Route 156 for about 2.2 miles to reach the Lyme Town Line.

Continue north on Route 156 for 4.5 miles.

Turn right onto Beaver Brook Road.

Continue on Beaver Brook Road for about 2.9 miles to the site.

The site is located at 322 Beaver Brook Road.

The sign is adjacent to the access drive.

Limited parking is available.

249 Hamburg Road, Lyme**

From Site – 322 Beaver Brook Road, Lyme

Turn right onto Beaver Brook Road.

Proceed on Beaver Brook Road for about 2.9 miles.

Turn left onto Hamburg Road (Route 156).

Proceed on Hamburg Road for about 2.1 miles.

The Lyme Public Hall is on the left.

Limited parking is available behind the Lyme Public Hall.

Additional parking is available next door at the First Congregational Church of Lyme.

Via Interstate 91 North (from points south of Hartford):

Take I-91 North to Exit 25 (Route 3 North).
Take Route 3 North to Route 2 East (towards Norwich).
Follow Route 2 Directions below.

Via Route 2 East and/or Route 11 South:

Proceed on Route 2 East (towards Norwich).
Take Exit 19 (Route 11 South) off of Route 2 East to Route 11 South.
Proceed on Route 11 South for about 7.4 miles.
Take Exit 4 (Route 82) off of Route 11 South.
At the end of the ramp, turn right onto Route 82 (East Haddam Road).
Proceed on Route 82 for about 3.9 miles.
Turn left onto Route 156 (Hamburg Road).
Proceed on Route 156 (Hamburg Road) for about 3.8 miles.
The Lyme Public Hall is on the left.
Limited parking is available behind the Lyme Public Hall.
Additional parking is available next door at the First Congregational Church of Lyme.

Via Interstate 95 North (from points west of Old Lyme)

Take I-95 North to Exit 70.
At the end of the ramp, turn left onto Route 156 (heading north.)
Proceed north on Route 156 for about 2.4 miles to reach the Lyme Town Line.

**TO: The Hideaway Restaurant and Pub – Old Lyme Shopping Center,
19 Halls Road, Old Lyme**
From: Hearing Location (Lyme Public Hall)

Turn left onto Hamburg Road (Route 156).

Proceed on Route 156 for about 4.7 miles.

When you see a sign for Route 1 pointing to the left, turn left onto Halls Road.

Proceed on Halls Road for about 0.3 miles.

The Old Lyme Shopping Center is on the left.

The Hideaway Restaurant & Pub is located in the Old Lyme Shopping Center plaza.

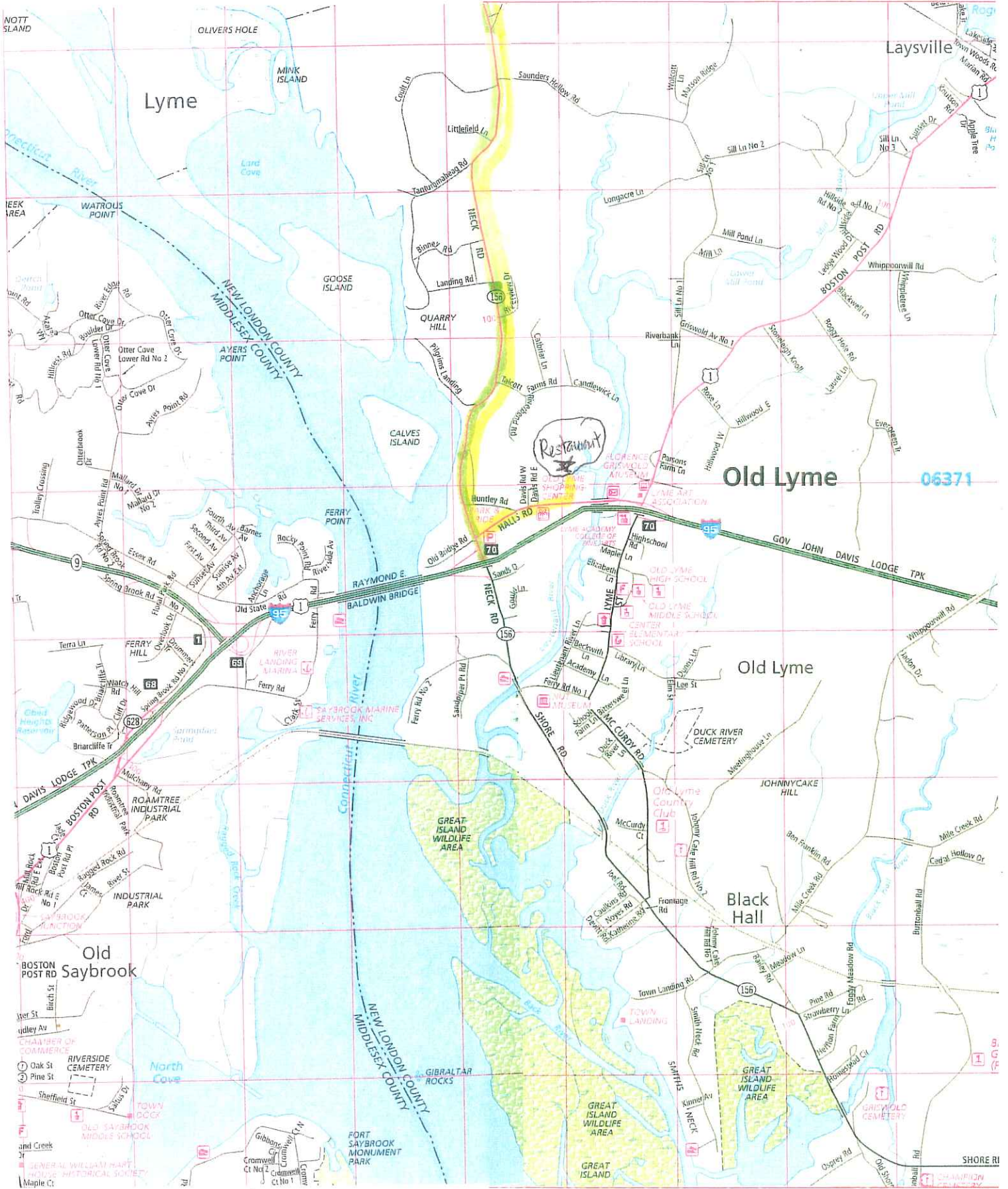
Map Key:

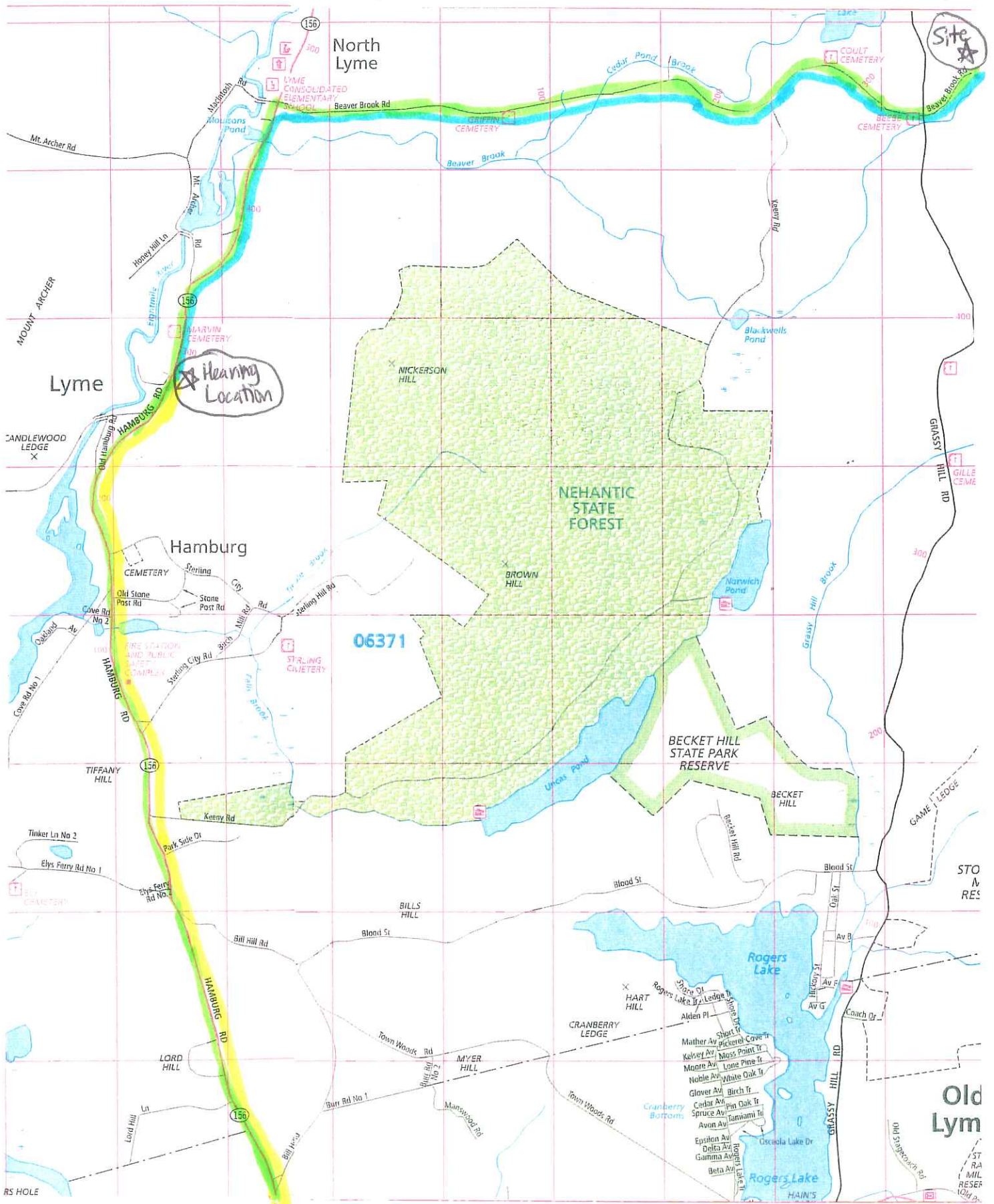
