Notice is hereby given that the transcript of the hearing was received at the office of the Connecticut Siting Council on October 15, 2009.

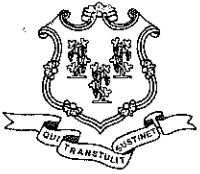


Dear :
