Notice is hereby given that the transcript of the hearing was received at the office of the Connecticut Siting Council on January 14, 2010.

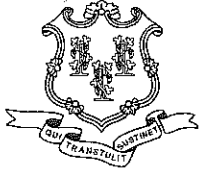


Dear Ms. Bean:
