DOCKET NO. 391 - T-Mobile Northeast, LLC application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance and operation of a telecommunications facility located 232 Shore Drive, Old Lyme, Connecticut.

DOCKET NO. 392 - T-Mobile Northeast, LLC application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance and operation of a telecommunications facility located 387 Shore Road, Old Lyme, Connecticut.

DOCKET NO. 393 - T-Mobile Northeast, LLC application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance and operation of a telecommunications facility located 61-1 Buttonball Road, Old Lyme, Connecticut.

On February 4, 2010, the Connecticut Siting Council (Council) held a public field review of all three sites, an evidentiary hearing for the Docket No. 391 (Self-storage) site, and a public comment session for all three sites. However, the evidentiary record for the Docket 391 self-storage tower proposal remains open for consideration of additional information associated with the height of the tower. Currently, the proposed height of the tower is 100 feet. T-Mobile (Applicant) would locate its antennas at 100 feet, and intervenor Verizon Wireless would locate its antennas at 90 feet.

According to the record for Docket 391, 90 feet is the minimum height that would be feasible for intervenor AT&T. Since the 90-foot and 100-foot positions are not available, AT&T seeks 110 feet for its antenna height. In addition, the Town of Old Lyme seeks to install its municipal antennas at 160 feet according to a Memorandum dated February 2, 2010 that was submitted by the Town at the Docket 391 evidentiary hearing held on February 4, 2010.

Given that the tower proposal has only been noticed for 100 feet, the Council notes that if the Applicant wishes to pursue a taller tower proposal (e.g. 110 feet or 160 feet), adequate notice must be provided and sufficient evidence needs to be submitted into the record to verify its need for such height. In addition, a taller tower will require that additional evidence regarding the environmental impacts be submitted to the Council. In any event, the applicant is asked to clarify the height for which it seeks Council approval, and to ensure sufficient notice is undertaken to facilitate Council consideration of that height.

The Council also requests that T-Mobile provide affidavits regarding the three balloon flights to certify the dates, times and most importantly, the heights at which the balloons were flown. Also, the Council requests that additional information and documentation specifically pertaining to Docket 391 that was requested by the Council during the February 4, 2010 evidentiary hearing be submitted on or before March 4, 2010.
