**INTERROGATORY RESPONSES TO INTERESTED PARTY MARY STALEY
FROM APPLICANT T-MOBILE NORTHEAST LLC**

The Applicant, T-Mobile Northeast LLC ("T-Mobile"), submits the following responses to the first set of Pre-Hearing Interrogatories propounded by an Interested Party, Mary Staley, in connection with the above-captioned Application for Certificate of Environmental Compatibility and Public Need ("Application").

1. Indicate whether you have updated Exhibit L that identified the distance between the proposed facility and the area residents? if so, submit a revised exhibit.
- A1 T-Mobile has updated Exhibit L to the Application, which is a list of residential buildings situated within 1000 feet of the proposed Facility. The updated list is appended hereto as Attachment A.**
2. The original Exhibit L did not include the residence located at 8-1 North Road. If this is not in the revised exhibit referenced in Interrogatory No. 1, include the distance to this residence.
- A2 The Tax Assessor's Office for the Town of Old Lyme does not have a listing for 8-1 North Road. This parcel appears to be Tax Lot 92-10, which is located at the corner of North Road and Shore Acres Road. Although this parcel has an access connecting to North Road, the Assessor's Office has listed the parcel as 7 Shore Acres Road (and not as a North Road address). T-Mobile included this parcel on its original Exhibit L and has included this parcel on its revised Exhibit L.**


