SUPPLEMENTAL PRE-FILED TESTIMONY OF MICHAEL P. LIBERTINE

The following pre-filed testimony supplements my pre-filed testimony filed on January 28, 2010, in connection with the above-captioned Application for a Certificate of Environmental Compatibility and Public Need for a telecommunications facility ("Facility") at 387 Shore Road, Old Lyme, Connecticut ("Property") submitted by T-Mobile Northeast LLC ("T-Mobile").

Q12. Did Vanasse Hangen Brustlin, Inc. ("VHB") conduct any research regarding the "snag" stealth tower design at the request of the Council?

A12. Yes. VHB did conduct some research regarding the "snag" stealth tower design. VHB's research did not yield a general schematic for "snag" stealth tower designs. VHB did, however, find an image of such a design per the Council's request. Please see the image appended hereto as Attachment A.

Q13. Did VHB perform additional analysis of the potential visual impact of the Facility along Shore Road and the Point-O-Woods development?

A12. Yes. The Facility would be visible year round on a total of six (6) parcels along Shore Road, four (4) of which are currently developed with residences. Three (3) additional residentially-developed parcels along Shore Road would have seasonal

views of the Facility. Views could be achieved from select portions of those properties and would primarily be limited to the upper portion of the Facility. This additional analysis incorporated digital parcel-level data and results in a fine-tuning of the conclusions made by VHB in its initial visual assessment of the Facility. Please see the viewshed appended hereto as Attachment B.

The Facility would also be visible to some residential properties in the Point-O-Woods development. Using the parcel-level data in the supplemental assessment allowed for a more accurate evaluation of the specific number of properties that may experience some level of visibility. Note that portions of a total of ten (10) parcels within the Point-O-Woods development are expected to have year-round views of the Facility, nine (9) of which are currently developed with residences. A total of nineteen (19) parcels are anticipated to have some seasonal views, thirteen (13) of which are currently developed with residences. The majority of these views, however, would be limited to the upper portions of the Facility.


Finally, per the Council's request, VHB contacted William Lacourciere, Chairman of the Point-O-Woods Water Pollution Control Authority, regarding the number of residential properties in the Point-O-Woods development hosting winterized dwellings. According to Mr. Lacourciere, approximately 430 residences are currently located within Point-O-Woods, of which approximately 50 to 60 are maintained as winterized dwellings. Please see email correspondence appended hereto as Attachment C.



Mike,

As you must know most of those at Point O' Woods who are aware of the proposed location of your tower adjacent to our community strongly object to its location. People object for various reasons including asthetics, the impact on the health of community members, especially children, and its visibility to residents of Point O' Woods. Also, you should be aware that many of our community belong to a homeowner's group that has just won a lawsuit with the town of Old Lyme allowing them to live at Point O' Woods year-round. Now that we have just successfully installed a community sanitary sewer collection system and year-round water, that possibility is a likely prospect for many of our homeowners. Then of course many more will be subjected to the unattractive view of your cell tower year round.

At present there are approximately 430 residences at Point O' Woods with approximately 50-60 of those year round. With the recent court ruling and the advent of the new municipal sewer and water services I expect that number will rise sharply.

Does this council have public hearings or meetings that our members or a representitive of our members can attend?

I understand the quandry. We all want good cell service and all complain if service isn't good and complain again when it's in our backyard. As a manufacturer of products and services myself I think it's up to you not us to solve that problem as I would in my business and find a way to site that tower in a more commercial or industrial location that still provides people on the immediate shoreline reliable service.

If there are meetings or hearings which we may attend we would appreciate learning more about meeting dates and location.

Thank you Bill

The Councils hold jurisdiction over the siting and permitting of utility projects in CT, including wireless telecommunications facilities. Although they hold the ultimate decision-making authority, the local municipalities act in a review and comment capacity. This specific Docket (#392) involved a proposed 80-foot tall, west of the Laundromat at 387 Shore Road, adjacent to the railroad tracks (north side). VHB is under contract with T-Mobile, who is the applicant to the Council. In addition to other services, VHB conducts a visibility analysis which predicts where the facility is likely to be visible after construction. Our analysis indicates that some properties in the northwest portion of the Point-o-Woods development may have views of at least a portion of the tower. The majority of these views are predicted to be limited to seasonal, or "leaf-off", times of the year. There are select areas where year-round views may be achieved, but we believe these views would be limited to the very top of the tower at or slightly above the tree canopy.
