RE: **DOCKET NO. 395** – New Cingular Wireless PCS, LLC application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance and operation of two telecommunications facilities located off of Haywardville Road and Ed Williams Road both in the Town of East Haddam, Connecticut.

The Connecticut Siting Council has scheduled a field review for this docket for Thursday, March 4, 2010. Council members will meet **at the parking lot for Devil's Hopyard State Park on Foxtown Road and then carpool** from there to the Devil's Hopyard South Site off of Ed Williams Road in East Haddam, Connecticut at 2:00 p.m. [*Note: Sites are in the woods; wear appropriate shoes in the event of inclement weather.*]

A public hearing is scheduled for Thursday, March 4, 2010, beginning at 3:00 p.m. in the Grange Hall at 488 Town Street (Route 151), East Haddam, Connecticut.

Directions to Parking Lot at Devil's Hopyard State Park

From Route 9 southbound or northbound

- Take Exit 7 (Route 82/East Haddam)
- At stop sign at end of exit road, turn left to follow Route 82 East and Route 154 North
- At first traffic light, turn right to follow Route 82 East
- Follow Route 82 East over bridge, past Goodspeed Opera and the Gelston House, to intersection with Route 151
- Turn right onto Route 151, then take immediate left onto Mount Parnassus Road
- Follow Mount Parnassus Road (it will become Millington Road and then Haywardville Road)
- Turn right onto Hopyard Road (at sign to Devil's Hopyard State Park)
- Turn left onto Foxtown Road (there will be another sign to the state park)
- Parking Lot will be immediately on left

To Devil's Hopyard South Site from Parking Lot

- From parking lot, turn left onto Foxtown Road
- At stop sign at end of Foxtown Road, turn left onto Ed Williams Road
- Site will be a short distance on right – look for markings

Directions to Devil's Hopyard North Site

- From South Site, retrace route from Ed Williams Road to parking lot
- From parking lot, turn right onto Foxtown Road then another right onto Hopyard Road
- At stop sign at end of Hopyard Road, turn left onto Haywardville Road
- Site will be short distance on right – look for markings

Directions to Hearing – Grange Hall

Grange Hall is at 488 Town Street (Route 151)

- From North Site, follow Haywardville Road/Millington Road/Mount Parnassus Road back to Route 82/151
- At stop sign at end of Mt. Parnassus Road, turn right onto Route 82
- At next stop sign, go straight ahead to stay on Route 151 (Town Street)
- Grange Hall will be on right, opposite cemetery

Directions to Restaurant – La Vita Gustosa

Restaurant is at 9 Main Street in East Haddam Village, phone is 860-873-8999

- From Grange Hall, turn left onto Town Street (Route 151)
- Turn right onto Route 82 and follow into center of East Haddam
- Restaurant is opposite the Gelston House, parking is behind restaurant (look for signs for East Haddam Village parking)
