  - b. please provide evidence of the current owner of the DEP Parcel based on the assessor's records of the Town of East Lyme;
  - c. please describe any and all contact the Town of East Lyme has had with the DEP concerning the DEP Parcel and concerning this application including the name(s) of all individuals at DEP that the Town has contacted, the dates of such contact and whether any contact has been made in writing;
  - d. Please produce copies of all correspondence between the Town of Lyme and DEP concerning the DEP Parcel and this application.

- 3. Does the Town of East Lyme currently have ownership, control or permitted use of the DEP Parcel?
- 4. Has the Town of East Lyme received any indications from the DEP that the DEP would be willing to lease the DEP Parcel for purposes of construction and maintenance of a telecommunications facility or otherwise permit a telecommunications facility on the DEP Parcel?
