SHERWOOD SUBSTATION

MARCH 3, 2010

1. Estimate the number of trees with a diameter at breast height of six inches or greater that would be removed to construct the substation and access drive.
2. Estimate the amount of cut and fill that would be required to prepare the substation site.
3. What is the distance (in feet) from the substation to the Green Farms Academy property? Playing fields? Academic building?
4. When would the equipment at the Green Farms substation be removed?
5. In correspondence from CL&P to the Town Planning and Zoning Director dated September 23, 2009 (Exhibit 6), CL&P states a drainage analysis was provided to the Westport DPW for review and comment. Did the DPW comment? If so, please provide.
