Directions to Site

Site is located at 166 Pawcatuck Avenue in the Pawcatuck section of Stonington.

From Interstate 95 northbound

- Take Exit 91 (Route 234/North Main Street/Stonington Borough)
- At first traffic light, go straight to follow Route 234 – Pequot Trail
- Follow Route 234 to intersection with Route 1, turn left onto Route 1 (Broad Street)
- Follow Route 1 into center of Pawcatuck; turn right **immediately** after going under railroad bridge onto Mechanic Street
- From Mechanic Street, turn right onto Clark Street
- Clark Street will turn left and become Pawcatuck Avenue
- Follow Pawcatuck Avenue to end; site property will be on right (look for red utility shed)

To Hearing from Site

Hearing will be in the Stonington Community Center, 28 Cutler Street, Stonington.

- From site, retrace steps to Route 1 (Broad Street)
- Turn left onto Route 1 to go under railroad bridge
- Follow Route 1 to intersection with Route 1A
- Bear left onto Route 1A and follow Route 1A toward Stonington Village
- Approaching Stonington Village, where sign indicates Route 1A goes to right, turn left onto Trumbull Avenue
- At next stop sign, turn left onto Cutler Street
- From Cutler, first driveway on left will be entrance to Community Center

To Hearing from I-95

- Take Exit 91 (Route 234/North Main Street/Stonington Borough)
- At first traffic light, turn right onto Pequot Trail
- From Pequot Trail, turn left onto North Main Street (at sign to Route 1)
- Follow North Main Street to stop sign at Trumbull Avenue (soccer field will be on left)
- Turn left onto Trumbull Avenue and follow to Cutler Street
- At stop sign at Cutler Street, turn left
- From Cutler, first driveway on left will be entrance to Community Center

To Restaurant

Dinner will be at the Dog Watch Café, 194 Water Street, 860-415-4510.

- From Community Center, turn right onto Cutler Street, then first right onto Trumbull Avenue
- At stop sign, turn left to go over viaduct into Stonington Village
- Take a hard right immediately at end of viaduct to go north on Water Street
- Dog Watch Café will be a short distance on left
