To Site via Interstate 84 East (Hartford area)

From Hartford, follow Interstate 84 East to Exit 68.
At end of Exit 68 ramp, follow Route 195 East towards Mansfield for approximately 0.8 mile.
At intersection with Route 44 (traffic light), turn left onto Route 44 East.
Follow Route 44 East approximately 0.4 mile and turn left onto Daleville Road.
Site is at 343 Daleville Road on right.

To Site from Norwich Area

From Route 2, take Route 32 exit.
Follow Route 32 North to Route 44 in Mansfield Depot.
Follow Route 44 East past intersection with Route 195 for approximately 0.4 mile and turn left onto Daleville Road.
Site is at 343 Daleville Road on right.

To Town Hall from Site

Return to Route 44 and turn right.
Follow Route 44 to Route 195 (traffic light) and turn right onto Route 195 west.
Immediately turn right onto Route 320 north (traffic light).
Follow Route 320 to Route 74 – town common is across road.
Turn right then immediately left at traffic light onto Jared Sparks Road.
Old Town Hall is on left along common.

To Town Hall from I-84

Take Exit 69, Route 74.
Follow Route 74 east through West Willington (Route 32 area).
Pass intersection with Route 320.
At traffic light at top of hill, turn left onto Jared Sparks Road.
Town Hall is white clapboard building on left at intersection with Common Road.
