PETITION TO INTERVENE

Pursuant to Connecticut General Statutes ("C.G.S.") Section 16-50n and Regulations of Connecticut State Agencies ("R.C.S.A.") Section 16-50j-15a, Cellco Partnership d/b/a Verizon Wireless ("Cellco") hereby requests permission of the Siting Council ("Council") to participate, as an intervenor in the application and hearing process for Docket No. 401.

As the Council is aware, Cellco is a licensed provider of wireless services in Fairfield County, Connecticut.
