The Connecticut Siting Council (Council) received an application for a Certificate of Environmental Compatibility and Public Need, pursuant to General Statutes § 16-50*l*. This request will be placed on a future meeting agenda to adopt a schedule which will include a public hearing in your neighboring town. A copy of the agenda will be sent to you.

Pursuant to General Statutes § 16-50x(a), municipalities may provide to the Council location preferences or other criteria for the siting of telecommunications towers that are brought to the Siting Council for approval. The Council requests submission of these comments by June 7, 2010. Connecticut General Statute § 16-50l(p) provides for municipalities within 2,500 feet of a proposed facility to receive adequate notice of the project. The Town of Sharon is within 2,500 feet of the proposed facility.

Please be advised that your involvement with the Council process may occur in various ways, such as written comments, party status, and/or participation in the public hearing. Please contact me if you have any questions or comments regarding this proposal or your role in the Siting Council process. Thank you for your cooperation and consideration.
