The Connecticut Siting Council (Council) is in receipt of the request for an extension of construction time in this docket dated August 4, 2017. Pursuant to Condition No. 8 of the Certificate dated October 21, 2010, the Council hereby grants this fourth request for an extension of construction time in this docket until April 25, 2019, to complete the construction of this facility.

Pursuant to Condition Nos. 8 and 9 of the Certificate, any request for an extension to fully construct this telecommunications facility with at least one fully operational wireless telecommunications carrier shall be filed with the Council not later than 60 days prior to the expiration of this Certificate and shall be served on all parties and intervenors, as listed on the current service list and the Town.

This extension is granted with the understanding that the Council will be notified should the Certificate Holder decide not to proceed with construction.
