NOTIFICATION PURSUANT TO C.G.S. § 16-50I(e)

Pursuant to Connecticut General Statutes § 16-50I(e), attached are materials which Cellco Partnership d/b/a Verizon Wireless (“Cellco”) is required to provide to the Siting Council (“Council”) in connection with the development of a proposed wireless telecommunications facility at one of two locations in the Town of Voluntown, Connecticut (the “Voluntown Facility”). These materials include:

1. All materials provided to the Town of Voluntown;
2. A summary of the consultations with representatives and officials from the Town of Voluntown, including any recommendations on the proposed telecommunications facility; and
3. Copies of any and all correspondence between the Applicant and the Town of Voluntown.

A. Materials Provided to the Town of Voluntown

- Technical Report dated June 14, 2010, prepared by Cellco. This Technical Report included a description of two alternative wireless facility locations, one at 422

Rockville Road (“Site 1”) and the second at 81 James Road (“Site 2”). Copies of the Cellco Technical Report were submitted to the Council as a Bulk File Exhibit on September 2, 2010.

B. Summary of Municipal Consultations

- On June 14, 2010, Cellco representatives met with the Town of Voluntown’s First Selectman, Ronald Millovitsch, Selectman Willis Maynard and Planning and Zoning Commission Chair Robert Hanson to discuss Cellco’s need for wireless service in Voluntown and its plans for the development of a wireless facility at either the Site 1 or Site 2 location. Cellco submitted copies of its Technical Report to the Town official and discussed the need for the Voluntown Facility.
- At the request of the Town officials, Cellco hosted a Public Information Meeting on July 21, 2010 at Voluntown Town Hall. Notice of that meeting was sent to the owners of land abutting the 422 Rockville Road and 81 James Road parcels.

C. Copies of all correspondence between the Cellco and the Town of Voluntown

- Cellco’s Technical Report was filed with the Council on September 2, 2010.
