

PUBLISHER'S CERTIFICATE

LEGAL NOTICE

is hereby given, pursuant to Section 16-100 of the Connecticut General Statutes and provisions pertaining thereto, of an Application submitted to the Connecticut Siting Council ("Council") on or about September 2, 2010, by Cellco Partnership d/b/a Verizon Wireless ("Cellco" or the "Applicant"). The Application concerns the installation of a wireless communications facility at one of two locations within the Town of Voluntown, Connecticut. The Site 1 would consist of a 50' x 50' compound within a 11.2 acre parcel at 422 Rockville Road at this site, Cellco proposes to construct a tower. Access to Site 1 will extend from Rockville Road. The Site 2 location would consist of a 50' x 50' compound area within a 9.5 acre parcel at 81 James Road. At this site, Cellco proposes to construct a 160-foot tower. Cellco will also install a new 12' x 24' shelter located near the approved tower to house its radio equipment and an emergency generator. The tower and other features of the proposed facility are subject to change under provisions of the Connecticut General Statutes § 16-50g et. seq.

At the day of the Siting Council public hearing on the proposed, Cellco will fly a balloon at the height of the proposed towers described above.
