NOTICE OF INTENT TO BE A PARTY

Pursuant to Connecticut General Statutes ("C.G.S.") Sections 4-177a and 16-50n (a), and Regulations of Connecticut State Agencies ("R.C.S.A.") Section 16-50j -14, I, Heike M. Krauland, hereby request permission of the Siting Council ("Council") to participate, as a party, in the application and hearing process for Docket No. 408.

Section 16-50n (a) provides, in relevant part that "[p]arties to a certification or amendment proceeding or to a declaratory ruling proceeding shall include . . .
