Carol and I have reviewed the December 13, 2010 letter from Cuddy & Feder that you received. I offer the following comments regarding their request:

- Cuddy & Feder asked “ *We understand that Class I and Class II watershed lands are barred for such use by State statute and as such, we are trying to determine if any of the watershed property in this area is Class III and if so, would they be available for use as a possible wireless facility tower site.*”
- We reviewed the classification of MDC lands in the AT&T search area (See attached Map). The MDC property in this area is all classified as Class I or Class II. There is no Class III land owned by the MDC in this area.
