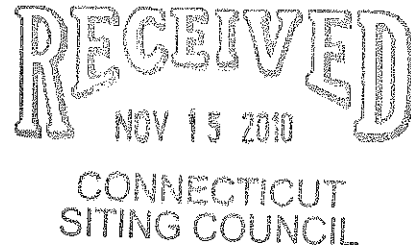

LEGAL NOTICE

Notice is hereby given, pursuant to Section 16-50l(b) of the Connecticut General Statutes and Regulations pertaining thereto, of an Application to be submitted to the Connecticut Siting Council ("Council") on or about October 20, 2010, by Cellco Partnership d/b/a Verizon Wireless ("Cellco" or the "Applicant"). The Application proposes the installation of a wireless telecommunications facility in Milford, Connecticut. The installation would consist of a 1,405 square-foot leased area within a 2.7 acre parcel located at 234 Melba Street, owned by Melba Realty LLC. At this site, Cellco proposes to construct a 136-foot flagpole tower. Access to the site will extend from Melba Street over an existing paved driveway a distance of 405 feet to the cell site. Cellco will also install a 12' x 24' shelter located near the base of the tower to house its radio equipment and a propane-fueled back-up generator. Cellco will place a 1,000 gallon propane tank within the fenced compound. The location and other features of the proposed facility are subject to change under provisions of Connecticut General Statutes § 16-50g et. seq.

On the day of the Siting Council public hearing on this proposal, Cellco will fly a balloon at the height of the proposed tower described above. Interested parties and residents of the City of Milford are invited to review the Application on or after October 21, 2010, during normal business hours at any of the following offices:
