#### TO FIELD REVIEW - 234 Melba Street

#### Via Interstate 91 South (from points north of New Haven):

Take I-91 South to New Haven area. Take Interstate 95 South.

Follow I-95 directions below.

## Via Interstate 95 South (from points east of Milford)

Proceed on Interstate 95 South (towards Milford).

Take Exit 40 (Woodmont Road) off of I-95 South.

Turn left onto Woodmont Road.

Proceed on Woodmont Road for about 0.1 miles.

Turn right onto Old Gate Lane.

Proceed on Old Gate Lane for about 1.1 miles.

When Old Gate Lane ends, the road will fork.

Bear right at the fork onto New Haven Avenue (Route 162).

Proceed on New Haven Avenue for about 0.7 miles.

Turn left onto Buckingham Avenue.

Proceed on Buckingham Avenue for 1.5 miles until it ends.

Turn left onto Melba Street.

Proceed 0.2 miles to 234 Melba Street.

The site is on the left, behind a two-building plaza.

The site is located behind the first (unmarked) building in that plaza.

The second building is marked Beachside Supermarket.

### Via Interstate 95 North (from points west of Milford)

Proceed on Interstate 95 North (towards Milford).

Take Exit 40 (Old Gate Lane / Woodmont Road) off of I-95 North.

Turn right onto Old Gate Lane.

Proceed on Old Gate Lane for about 0.8 miles.

When Old Gate Lane ends, the road will fork.

Bear right at the fork onto New Haven Avenue (Route 162).

Proceed on New Haven Avenue for about 0.7 miles.

Turn left onto Buckingham Avenue.

Proceed on Buckingham Avenue for 1.5 miles until it ends.

Turn left onto Melba Street.

Proceed 0.2 miles to 234 Melba Street.

The site is on the left, behind a two-building plaza.

The site is located behind the first (unmarked) building in that plaza.

The second building is marked Beachside Supermarket.

## TO HEARING LOCATION: Milford City Hall Auditorium 110 River Street, Milford

#### From Site - 234 Melba Street, Milford

Turn right onto Melba Street.

Proceed on Melba Street for 0.2 miles.

At the stop sign and flashing red light, turn right onto Buckingham Avenue.

Proceed on Buckingham Avenue for 1.5 miles.

Turn left onto New Haven Avenue (Route 162 west).

Proceed on Route 162 west for about 0.7 miles.

Turn right onto Daniel Street.

Turn right onto River Street.

Proceed on River Street for about 0.07 miles.

The road will fork.

Bear right to continue on River Street.

Continue on River Street for 0.08 miles.

The Milford City Hall is located on the left at 110 River Street.

Free parking is available in the Superior Court lot, on the street, or any other lot.

(Looking at the front of City Hall, the Superior Court is to the left.)

### Via Interstate 91 South (from points north of New Haven):

Take I-91 South to New Haven area.

Take Interstate 95 South.

Follow I-95 directions below.

### Via Interstate 95 South (from points east of Milford)

Proceed on Interstate 95 South (towards Milford).

Take Exit 39A (Route 1 South) off of I-95 South.

Merge onto Route 1 South.

In about 0.2 miles, the road will fork.

Bear left at the fork to continue onto Cherry Street.

Proceed on Cherry Street for about 0.8 miles.

Turn left onto River Street.

Proceed 0.1 miles to 110 River Street.

The Milford City Hall is located on the right at 110 River Street.

Free parking is available in the Superior Court lot, on the street, or any other lot.

(Looking at the front of City Hall, the Superior Court is to the left.)

### Via Interstate 95 North (from points west of Milford)

Proceed on Interstate 95 North (towards Milford).

Take Exit 37 (High Street) off of I-95 North.

Turn right onto High Street.

Proceed on High Street for about 0.5 miles.

Turn left onto West Main Street.

Proceed on West Main Street for about 0.4 miles.

Turn right onto River Street.

Proceed 0.1 miles to 110 River Street.

The Milford City Hall is located on the right at 110 River Street.

Free parking is available in the Superior Court lot, on the street, or any other lot.

(Looking at the front of City Hall, the Superior Court is to the left.)

## TO: Rainbow Gardens Restaurant and Bar 117 North Broad Street, Milford

## From: Hearing Location (Milford City Hall)

Turn right onto River Street.

Proceed on River Street for about 0.2 miles.

Turn right onto North Broad Street (Route 162 West).

Proceed 0.2 miles to 117 North Broad Street.
