#### **Directions to Site**

Site is located at 1363 Boston Post Road in Old Saybrook, Connecticut.

### From Hartford, New Britain, Meriden, Enfield, Wolcott, Norfolk

- Take Route 9 southbound to Exit 2 (Route 154/Middlesex Turnpike/Old Saybrook)
- At end of exit ramp, turn right and follow Route 154 to Route 1
- At intersection of Routes 154 and 1, continue straight to follow Route 1 (Boston Post Road)
- Follow Route 1 to Site—host property will be on right immediately after Dairy Queen, which is on left side of Route 1
- Turn right onto Tompkins Road after sign for Tang Soo Do martial arts academy and Speed Racing shop
- Site is on right at end of Tompkins Road, beyond Electrical Wholesalers

### From Milford and Fairfield:

- Take I-95 northbound to Exit 66 (Route 166 Spencer Plain Road)
- Turn right at end of exit ramp to follow Route 166 Spencer Plain Road to intersection with Route 1 (Boston Post Road)
- At intersection, turn left onto Route 1
- From Route 1, turn left onto Tompkins Road, immediately after Days Inn, which will be on right
- Site is on right at end of Tompkins Road, beyond Electrical Wholesalers

#### From Stonington

- Take I-95 southbound to Exit 66 (Route 166 Spencer Plain Road)
- Turn left at end of exit ramp to follow Route 166 Spencer Plain Road to intersection with Route 1 (Boston Post Road)
- At intersection, turn left onto Route 1
- From Route 1, turn left onto Tompkins Road, immediately after Days Inn, which will be on right
- Site is on right at end of Tompkins Road, beyond Electrical Wholesalers

## To Hearing from Site

Hearing will be in the Acton Public Library at 60 Old Boston Post Road, Old Saybrook, Connecticut.

- From Tompkins Road, turn left onto Route 1 and follow to intersection with Route 154 (at Shell Station on right)
- Turn right onto Route 154 and then continue straight onto Old Boston Post Road
- Library is on right shortly after Kathleen Goodwin elementary school; parking is in rear of library
