Directions to Site

Site is located at 723 Leetes Island Road in Branford, Connecticut.

From Hartford, New Britain, Meriden, Enfield, Wolcott, Norfolk:

- Take Interstate Highway 91 southbound and then travel on Interstate Highway 95 northbound to Exit 56 (Leetes Island Road/Stony Creek).
- At end of exit ramp, turn right to follow Leetes Island Road southbound.
- At stop sign at Stony Creek Package Store, turn left to follow Route 146 (Leetes Island Road) eastbound.
- Site will be on right, opposite Medlyn Farm vegetable stand.

From Milford and Stamford:

- Take I-95 northbound to Exit 56 (Leetes Island Road/Stony Creek).
- At end of exit ramp, turn right to follow Leetes Island Road southbound.
- At stop sign at Stony Creek Package Store, turn left to follow Route 146 (Leetes Island Road) eastbound.
- Site will be on right, opposite Medlyn Farm vegetable stand.

From Stonington

- Take I-95 southbound to Exit 56 (Leetes Island Road/Stony Creek).
- At end of exit ramp, turn left onto East Industrial Road.
- At intersection with Leetes Island Road, turn left to travel southbound.
- At stop sign at Stony Creek Package Store, turn left to follow Route 146 (Leetes Island Road) eastbound.
- Site will be on right, opposite Medlyn Farm vegetable stand.

To Hearing from Site

Hearing will be at the Italian-American Social Club at 40 Hamre Lane in Branford.

- From the site, turn left onto Leetes Island Road to travel westbound.
- At stop sign at Stony Creek Package Store, continue straight ahead to follow Route 146, which will now become Stony Creek Road.
- Continue straight where route sign says Route 146 goes left to follow Damascus Road.
- Turn right at next stop sign onto Windmill Hill Road.
- Turn left at stop light onto Route 1 East Main Street.
- Bear left from Route 1 at Global gas station to follow Main Street.
- Turn left onto Hamre Lane look for yellow fire hydrant on left; Hamre Lane will be immediately after fire hydrant.
- Italian-American Club will be at end of street on the left.

To Restaurant

Dinner will be at Donovan's Reef, 1212 Main Street in Branford. Phone is 203-488-5573.

- From Italian-American Club, return to Main Street and turn left.
- From Main Street, take right at traffic light onto Ivy Street.
- From Ivy Street, take quick left into first driveway into small shopping plaza.
- Follow driveway around to right to restaurant.
