NOTIFICATION PURSUANT TO C.G.S. § 16-50l(e)

Pursuant to Connecticut General Statutes § 16-50*l*(e), attached are materials which Cellco Partnership d/b/a Verizon Wireless ("Cellco") is required to provide to the Siting Council ("Council") in connection with its proposed wireless telecommunications facility on property at 87 West Quasset Road, Woodstock, Connecticut (the "Woodstock Relo Facility"). These include:

- 1. All materials provided to the Town of Woodstock;
- 2. A summary of the consultations with the Town of Woodstock, including any recommendations on the proposed telecommunications facility; and
- Copies of any and all correspondence between the Cellco and the Town of Woodstock.

A. Materials and Information Provided to the Town of Woodstock

Technical Report dated September 17, 2010, prepared by Cellco. This information includes a description of the proposed wireless facility, the need for such facility and a discussion of alternative sites considered. Copies of the technical information were submitted to the Council as a Bulk File Exhibit on January 28, 2011.

B. Summary of Municipal Consultations

Municipal consultation on a proposed Woodstock Facility relocation application commenced in the Fall of 2007, at about the same time that Cellco was pursuing its Sherman Road cell site in Docket No. 369. The need to upgrade the Woodstock Facility was discussed again in August of 2009, when Cellco was pursuing its East Woodstock Facility approvals in Docket No. 397. At that time, Cellco was discussing with the Town, its overall plan for providing telecommunications services in Woodstock.

Over the next three to four years, Cellco representatives remained in contact with the First Selectman and with the members of the Town's Telecommunications Task Force about the need to modify and perhaps relocate its existing Woodstock Facility. On September 17, 2010, Cellco representatives met with First Selectman Alan Walker to formally kick-off the municipal consultation period. Mr. Walker received copies of Cellco's Woodstock Facility Technical Report at that time. On October 25, 2010, Cellco representatives appeared before the Woodstock Telecommunications Task Force. At this meeting, Cellco's representatives discussed the need to modify the existing Woodstock Facility and described the Siting Council process.

C. Copies of all correspondence between the Cellco and the Town of Woodstock

Copies of the Woodstock Facility Technical Report were submitted to the Council as a bulk file exhibit on January 28, 2011.
