TO FIELD REVIEW

Via Interstate 95 from New Haven Area

Follow Interstate 95 northbound to Exit 56.

At end of ramp, turn right onto Leetes Island Road. Proceed approx. 1.5 miles At stop sign, turn left following signs for Route 146 (Leetes Island Road). Follow Route 146 East.

After railroad underpass, proceed approx. 0.6 miles

Turn left onto Sanborn Road - Road (merges into Moose Hill Road)

Site is on right after railroad overpass (before 83 Moose Hill Road).

Park along side street to left (Dromara Road).

Via Interstate 95 from Old Saybrook

Follow Interstate 95 southbound to Exit 59.

Turn right at end of ramp onto Goose Lane.

Go straight over I-95 and by Route 1.

Turn right onto Route 146 west.

Follow Route 146 through Guilford for a few miles.

After railroad underpass, follow Route 146 approx. 1.3 miles.

Turn right onto Moose Hill Road (one way).

Site is on right after railroad overpass (before 83 Moose Hill Road).

Park along side street to left (Dromara Road).

TO COMMUNITY CENTER

From Site

From site, follow Moose Hill Road back to Route 146.

Turn left onto Route 146.

At stop sign in Guilford town, turn left onto Route 77 north, keep town green to right.

Route 77 turns right (Broad Street) then turns left (Church Street).

Community Center is on left at 32 Church Street.

Via Interstate 95

Follow I-95 to Exit 58.

Follow Route 77 south approx. 0.7 miles to Community Center on left.
