### **Directions to Site 2, 164 Old Colchester Road**

The two proposed sites are located in close proximity off of Old Colchester Road in Waterford, Connecticut.

From Hartford, New Britain, Meriden, Wolcott, Milford, Stamford, Norfolk, and Enfield:

- Take Interstate Highway 95 northbound to Exit 83 (Route 32 North/Norwich)
- Take Exit 83; the exit ramp will merge onto Huntington Street.
- From Huntington Street, turn left at first traffic light onto Williams Street.
- Follow Williams Street northbound (Connecticut College will be on right).
- Williams Street will become Old Norwich Road, continue northbound.
- From Old Norwich Road, turn left onto Old Colchester Road at Quaker Hill Post Office (white building on left – Antinore’s Pizza will be on right just before intersection).
- Follow Old Colchester Road to #164 – driveway will be on left opposite Connecticut Humane Society.

From Stonington:

- Take Interstate Highway 95 southbound to Exit 84S-N-E (Downtown New London; 32 Norwich).
- Follow directions to Route 32 northbound to Norwich.
- From Route 32, turn left onto Fitzgerald Avenue.
- Follow Fitzgerald Avenue to end and turn right onto Old Norwich Road.
- From Old Norwich Road, turn left onto Old Colchester Road at Quaker Hill Post Office (white building on left – Antinore’s Pizza will be on right just before intersection).
- Follow Old Colchester Road to #164 – driveway will be on left opposite Connecticut Humane Society.

### **To Hearing from Site(s)**

Hearing will be at the Waterford Town Hall, 15 Rope Ferry Road (Route 156) in Waterford.

- From the site, turn right onto Old Colchester Road.
- At Quaker Hill Post Office, turn right onto Old Norwich Road and follow onto Williams Street.
- Follow Williams Street to stop sign at Briggs Street, turn right onto Briggs Street and follow signs to get onto I-95 southbound to New Haven.
- From I-95 southbound, take exit 82 (Rt 85/Broad Street, Waterford).
- Turn left at end of exit ramp onto Route 85 – Hartford Turnpike.
- From 85/Hartford Turnpike, turn right onto Jefferson Avenue (at New London town line).

- From Jefferson Avenue, turn right onto Chester Street (school will be in front of you).
- From Chester Street, turn left onto Clark Lane.
- From Clark Lane, turn right at intersection with Route 1-Boston Post Road.
- From Route 1, turn left onto Route 156 (Rope Ferry Road), shortly after Ocean State Job Lot sign.
- Town Hall will be immediately on right.

#### **To Restaurant**

Dinner will be at Filomena's Restaurant, 262 Boston Post Road in Waterford. Phone is 860-437-1010.

- From Town Hall, turn right onto Rope Ferry Road.
- From Rope Ferry Road, turn right at traffic light onto Avery Lane.
- At next traffic light, turn left onto Route 1.
- Restaurant is in Utopia Centre shopping strip, on left just beyond Waterford Post Plaza.
