NOTIFICATION PURSUANT TO C.G.S. § 16-50(e)

Pursuant to Connecticut General Statutes § 16-50(e), attached are materials which Cellco Partnership d/b/a Verizon Wireless (“Cellco”) is required to provide to the Siting Council (“Council”) in connection with the development of a proposed wireless telecommunications facility at one of two locations off Old Colchester Road in the Town of Waterford, Connecticut (the “Waterford NE Facility”). These materials include:

1. All materials provided to the Town of Waterford;
2. A summary of the consultations with representatives and officials from the Town of Waterford, including any recommendations on the proposed telecommunications facility; and
3. Copies of any and all correspondence between the Applicant and the Town of Waterford.

A. Materials Provided to the Town of Waterford

- Technical Report dated July 8, 2010, prepared by Cellco. Copies of Cellco's Technical Report were submitted to the Council as a Bulk File Exhibit on May 20, 2011.


B. Summary of Municipal Consultations

- On July 8, 2010, Cellco representatives met with First Selectman Daniel Stewart and Planning Director Thomas Wagner, to discuss Cellco's need for wireless service in northeast Waterford and its plans to develop a wireless facility at 164 Old Colchester Road. Cellco submitted copies of its Technical Report to Mr. Stewart and Mr. Wagner and the Council process.
- At the July 8, 2010 meeting, the First Selectman asked Cellco to consider an adjacent municipal parcel at 146 Old Colchester Road as an alternative to the proposed facility location.
- On September 21, 2010, the Waterford Board of Selectmen held a public hearing on the proposal to lease land at 146 Old Colchester Road to Cellco for the construction of a telecommunications facility. Cellco's representatives made a formal presentation at that time to the Board of Selectmen and members of the public in attendance.
- The proposal to lease municipal property to Cellco for the proposed tower site was also approved at a separate meeting by the Town's Planning and Zoning Commission and Park and Recreation Commission.

C. Copies of all correspondence between the Cellco and the Town of Waterford

- Cellco's Technical Report was filed with the Council on July 8, 2010.
