In accordance with the requirement of section 16-50o(c) of the General Statutes, that an "applicant shall submit into the record the full text of the terms of any agreement, ...entered into by the applicant and any party to the certification proceeding... in connection with the construction or operation of the facility," The Connecticut Light and Power Company (CL&P) submits herewith an original and 20 copies of a letter agreement dated May 5, 2009 between CL&P and Mount Hope Montessori School, Inc.

In accordance with the provision of section 16-50o(c) requiring that the applicant also submit "a statement of any consideration [for the agreement] if not contained in such agreement," CL&P states that there was no consideration for the agreement.

The potential transaction contemplated by the letter agreement did not occur.

Re: Lot 2, South Eagleville Road, Dunham Farm Estates, Storrs, Connecticut (the "Lot")

Ladies and Gentlemen:

You, Mount Hope Montessori School, Inc., have been discussing with The Connecticut Light and Power Company ("CL&P") the possible relocation of your School from your property at 48 Bassetts Bridge Road in Mansfield, in which case you have also indicated that you wish to have CL&P or another party purchase your property.

As you know, CL&P has not reached any agreement with you regarding such matters on the purchase of your property or the relocation of your School, and it is premature to say whether CL&P and you will be able to reach agreement on mutually agreeable terms. In the meantime, you have located the above-referenced Lot that you have identified as a possible location for the relocation of the School, and you have asked CL&P to make arrangements to purchase the Lot now, after the opportunity to perform some due diligence on the feasibility of the Lot for a school, to help preserve it as a possible site for relocation.

This letter serves to confirm our mutual understanding of the facts underlying this arrangement set forth above and our mutual agreement regarding the following:

- 1. You agree that if CL&P or one of its affiliates should (i) enter into a purchase and sale agreement to purchase the Lot, (ii) ultimately purchase the Lot, and/or (iii) pay for certain expenses as set forth in item 3 below, this will not create any obligation (a) to you of any kind, (b) on our part or (c) on the part of any affiliate of CL&P or other party related to CL&P. You also agree that, if CL&P acquires the Lot, CL&P is not under any obligation to sell or otherwise transfer the Lot to you, or to enter into any purchase and sale agreement with you regarding the Lot, before CL&P has obtained all the regulatory approvals CL&P deems are necessary in order for CL&P to sell or otherwise transfer the Lot.
- 2. Based on the foregoing, should CL&P or one of its affiliates be able to enter into a purchase and sale agreement with the owner of the Lot on terms acceptable to us and/or our affiliate, you agree that you will make immediate arrangements with Kenneth Boroson Architects to conduct studies of the Lot to determine its feasibility for use as an

elementary school consisting of approximately 6500 square feet, with related improvements such as parking, site improvements, septic system and drinking water well, and the feasibility of obtaining all necessary governmental approvals for the same, to be completed and with copies to be delivered to us no later than May 22, 2009.

- 3. We agree that we will pay for the cost of such studies upon presentation of copies of the final reports to us no later than May 22, 2009, together with invoices for the studies, but such payment will not exceed the amount of \$5,000.
- 4. You agree that CL&P's decision or that of one of its affiliates to proceed with the closing on the Lot shall be entirely in CL&P's or such affiliate's sole discretion, as the case may be, and that unless CL&P (or one of its affiliates) and you reach mutually agreeable terms in a written agreement at some point in the future on the purchase of the property at 48 Bassetts Bridge Road that includes the conveyance of the Lot to you, there shall be no obligation to convey such property to you.
- 5. You hereby assign and release to us, our successors, and assigns any and all interest and rights you may have to the Lot, under your contract with the seller dated March 12, 2009, or otherwise.

Please confirm your agreement to the terms and provisions of this letter by signing one copy of the letter where provided and returning it to the undersigned.
